A bylaw to amend Animal Control Bylaw No. 651, 2010

---

**WHEREAS** pursuant to Section 8 (3) (k) of the *Community Charter* Council may by bylaw regulate, prohibit and impose requirements in relation to animals;

**AND WHEREAS** pursuant to Section 194 of the *Community Charter* Council may establish fees;

**AND WHEREAS** the Council may amend its bylaws from time to time when deemed appropriate:

**NOW THEREFORE** the Council of the Village of Pemberton in open meeting assembled **ENACTS AS FOLLOWS:**

1. **CITATION**

This Bylaw may be cited as "Village of Pemberton Animal Control (Fee Schedule) Amendment Bylaw No.779, 2015".

2. **APPLICATION**

Village of Pemberton Animal Control Bylaw No. 651, 2010 be amended as follows:

2. Licencing of Dogs

Schedule 1 of Bylaw No. 651, 2010 is hereby deleted and replaced with a new Schedule 1 which is attached hereto and forms part of this bylaw.

3. **SEVERABILITY**


