Key Topic of Discussion: Infrastructure Improvements to Pemberton Creek Bridge

Background: The Village of Pemberton would like to express appreciation and gratitude for the continued improvements to Highway 99, including the resurfacing work that was undertaken by MOTI between Whistler and Pemberton.

Discussion: The Pemberton Creek Bridge is situated in close proximity to multiple housing complexes within the Village of Pemberton; however it is owned and falls under the jurisdiction of the Ministry of Transportation and Infrastructure. The safety of residents as well as the preservation of infrastructure to ensure access to Pemberton is not impeded is of utmost concern and priority for Village Council:

- 1) Resident Safety: The low height of the Pemberton Creek Bridge that spans Highway 99 represents a public safety hazard during high water events, as there is insufficient clearance for the creek beneath when the water level rises. Due to seasonal weather trends, there is at minimum an annual occurrence of flooding due to the lack of clearance between the bridge and the creek, posing a severe risk to residents of nearby housing complexes. As such, the Village of Pemberton requests that the Bridge be raised to a level where it no longer represents a public safety hazard during high water events.
- 2) Protection of Infrastructure: The insufficient clearance between Pemberton Creek and the bridge that spans Highway 99 represents a hazard during high water events, as there is at minimum an annual occurrence of road flooding in this area when the water level rises. As such, this portion of the Sea to Sky highway is at risk of damage, posing a safety hazard on a high traffic area and the potential for deterioration to the bridge infrastructure. The Village of Pemberton requests that the Bridge be raised to a level where it no longer represents a hazard to the bridge infrastructure during high water events.

Request:

- 1) **Resident Safety:** Pemberton requests that MOTI continue to make public safety improvements along Highway 99 including raising the height of the Pemberton Creek Bridge to mitigate risk of flooding to nearby housing complexes during high water events.
- 2) **Protection of Infrastructure:** The Village of Pemberton requests that MOTI continue to execute asset management of Sea to Sky infrastructure by raising the height of the Pemberton Creek Bridge to mitigate the risk of detrimental highway flooding during high water events.

Key Topics of Discussion: Road Safety Improvements for Bike Tourism

Background: Bike tourism has become very popular in the Sea to Sky Corridor. However, many areas along this route do not have permanent bike lanes or sufficient road shoulders, presenting a public safety hazard for both cyclists and motorists. The safety of our residents and visitors is of the utmost importance to the Village of Pemberton Council.

Discussion: With the increase in popularity of road cycling, the cyclist/vehicular traffic conflicts on the Sea to Sky highway have grown exponentially. The Village of Pemberton supports bike tourism as it brings both financial and environmental benefits to the Sea to Sky Corridor. Unfortunately, due to the lack of adequate bike lanes/shoulders on Highway 99 from Whistler through to the Pemberton Meadows, road cycling has the potential for incidents that may result in serious injuries and even fatalities.

The Village aims to encourage events that promote tourism in the Corridor and as such support the economy in the Province. However, in 2017, Council was in the unfortunate position of denying such support to the renewal of the IRONMAN Canada Whistler event, due to overwhelming concern of the community over public safety. There are simply too many vehicle (Transport, Resource, Farming, Commuter) conflicts with cyclists: residents are frustrated and share Council's concern with the potential for serious incidents as a result of these conflicts.

Pemberton itself is growing in population; the residents and visitors that we attract are passionate about active lifestyle. The health benefits of cycling are numerous, but ironically, due to a lack of bike lanes and road shoulders along the Sea to Sky route, this activity that promotes health also puts people at a risk of bodily harm, including loss of life.

To mitigate the risk of such tragic incidents and allow the Village to support the Bike Tourism industry without concern for cyclist safety, the Village of Pemberton requests that funding be allocated towards the creation of adequate and permanent bike lanes and/or road shoulders along this route.

Request: The Village of Pemberton requests that MOTI allocate funds for the creation of adequate and permanent bike lanes and/or road shoulders on the Pemberton Meadows Road as well as throughout the Sea to Sky Highway.

Key Topics of Discussion: Impacts of increased tourism in the Pemberton area

Background: The Village of Pemberton appreciates the investment that the Province has made towards the promotion of tourism in the Sea to Sky area. The increase in popularity of outdoor recreation has brought positive economic impacts to our community as well as to the Province. Sadly, the increase in visitors has also brought negative impacts, such as human/wildlife conflicts, the closures of popular destinations due to unmanageable volume, and increased risk of wildfire in remote areas.

Discussion: The rapidly increasing popularity of adventure tourism has brought, ironically, threats to the natural environment that draws visitors to our area, as well as to the safety of the highway used to access it. Events such as the closure by the Province of Keyhole Falls hot springs due to increased human/wildlife conflicts and the safety challenges presented by the shocking parking overflow at Joffre Lakes in 2016 and again in 2017 serves to highlight the problem. We appreciate the Province's acknowledgement of the concerns at Joffre with the imposition of a no dog rule in the Park and look forward to further action being taken.

The additional volume without adequate resources to supervise and maintain the popular areas mentioned above, as well camping areas down the In-SHUCK-ch highway along Lillooet Lake, including the popular Strawberry Point, pose equally great concerns such as overflowing garbage receptacles, inadequate restroom facilities and most importantly campfires that are not properly extinguished and pose a serious risk of wildfire, given the remote forest areas where sites such as this exist. Given the wildfire state of emergency that the Province experienced last summer season, the fact that climate change indicates our environment's susceptibility to wildfire is unlikely to decrease, and the astronomical cost to the Province to manage wildfires, it is crucial that additional resources be allocated to patrol, monitor and enforce Provincial regulations in the backcountry.

Though strongly supportive of economic benefits generated by adventure tourism, the Village of Pemberton Council is equally committed to the preservation of our environment. While our surrounding natural area has the capacity to draw a significant boost to the tourism industry in British Columbia, such a draw will not continue if the very environment is threatened.

As such, we request that the Province match the investment made in tourism marketing with an investment in mitigating the resulting challenges of increased visitor volume.

Request:

That the Province match the investment made in tourism marketing with the allocation of funds for improvements to infrastructure and for additional patrols of remote recreation areas to ensure the protection of the environment that supports the local and Provincial tourism industry.

Key Topics of Discussion: Farm Status Exemption for properties within a municipality

Background: Agriculture is a critical part of the sustainable economy and the overall culture of Pemberton. Historically an agricultural community, the Pemberton Valley is home to over 70 farming units and the Village is committed to supporting the industry and the ability of local farm operators to derive sufficient income from their land.

Discussion: In the spring of 2018, the Village commissioned a study to explore the potential impacts of a Boundary Extension, to address such issues as community identity, elected representation, land use planning control, and improved service delivery.

One of the deliverables of the study was to determine tax implications for properties being brought into the municipal boundary. When considering the tax implications for farm properties, the availability of tax exemptions differs depending on whether the farm is located within a municipal boundary or a rural area. The Statutory Farm Tax Exemptions for a farm in a Provincial rural area include a full exemption for both Class 1 Farmers' dwellings and Farm improvements (specifically outbuildings), whereas those same Farmers' dwellings located in a municipality are fully taxable, and the exemption for Farm improvements is capped to a maximum of \$50,000 as opposed to fully exempt.

The study found the potential difference in property taxes to a sample farm property with an assessed value of \$600,000 (land and improvements) resulted in an estimated 33% increase in taxation should it become part of a municipality.

Boundary Extension is a common method for municipalities to increase their economic vitality and as such their ability to provide improved services to their residents. However, the Village supports the agricultural industry and has no interest in imposing a potential financial hardship on farm owners. Indeed, members of the farming community were the most outspoken in opposition to the Boundary Extension, and Council respects their reasoning.

It is the Village's understanding that the Province is committed to reducing barriers that may prevent the growth of communities and supporting the sustainability of the agricultural industry in British Columbia. Economic vitality and improved service delivery remain priorities of Council, therefore although the Village will not be pursuing the Boundary Extension in 2018, it is expected that it will be pursued in the future, at which time we hope that the farms within a municipality are recognized as equally deserving of the Farm Status tax exemptions provided to rural area farms.

Request: That the Province extend the Farm Status tax exemption provided to rural area farms to farms located within a municipality.

Key Topics of Discussion: Mount Currie Mountain Rock Avalanche Risk Mitigation

Background: The Village of Pemberton would like to extend our gratitude to the Province for funding the Mount Currie Landslide Risk Assessment (the Assessment) completed in early 2018 by BGC Engineering Inc. The Assessment found that there is the potential for rare but large-scale rock avalanches, the probability of which will likely increase as climate change affects slope stability.

Discussion: The provincially-funded Assessment (**Appendix A**) determined that though the likelihood of a large-scale rock avalanche was low, the impact would be catastrophic for the communities in the Pemberton Valley: Village of Pemberton, Lil'wat Nation and Electoral Area C of the Squamish-Lillooet Regional District (SLRD). A large-scale rock avalanche would generate extreme volumes of material moving at such a speed as to destroy everything in their path. Human lives, homes, businesses and critical infrastructure (such as the airport) are in the identified potential paths of the rock avalanches, which would also dam the Green and Lillooet Rivers, causing severe flooding in the entire valley.

While the Assessment also determined that we cannot remove or mitigate the hazard, it recommended measures to mitigate the risk. The recommendations include the installation of a geohazard monitoring system to gather data over time, allowing us to detect the precursor signs of a large-scale event. The implementation of the monitoring system requires several steps to be met: the scoping of monitoring systems to determine the most cost-effective solution, the purchase of specialized equipment, and the retention of individuals with the expertise to interpret the data.

Unfortunately, none of the three at-risk jurisdictions have the resources to carry out these steps (see **Appendix B**, letter from Lil'wat Nation, and **Appendix C**, letter from the SLRD). Council is therefore requesting the Province's support in implementing the recommendations of the assessment, to provide for the public safety of all residents of the Pemberton Valley.

Request: That the Province provide funding solutions for the installation, operation and ongoing data analysis of a geohazard monitoring system for Mount Currie mountain.
