RE: 2018 Draft Zoning & Sign Bylaw

On behalf of the Pemberton & District Chamber of Commerce, please accept this letter in regards to the 2018 Draft Zoning & Sign Bylaw.

After reviewing the 2018 VOP Zoning Draft and the feedback we have received from various PDCC Members the Pemberton & District Chamber of Commerce supports the proposed removal of any further "Drive Through Service" Zoning in C3 and the removal of "Drive Through Service" Zoning in C2.

Further the removal of any further "Drive Through Service" Zoning in C2 & C3, the Pemberton & District Chamber of Commerce board of directors recommends to remove the "Drive Through Service" zoning in C5 which was recently re-zoned to allow Drive Through Service.

With regards to the Town Centre C-1 Zone; i.e. Auto Repair Shop (*Black's Hot Wheels*) and Equipment Servicing, Rental and Repair Shop (*Valley Chainsaw and Recreational, Ltd.*)

The Pemberton & District Chamber of Commerce board of directors were split on this proposed zoning with 3 / Yes, 3 / No and 1 on the fence.

We all agreed that while the Pemberton Chamber fully understands and support the concept of redevelopment and enhancement of the downtown core, but this tact doesn't feel right. To change the status specifically on these two long standing local businesses from a site-specific permitted use to 'lawful non-conforming' will not only hinder them from making any alterations or additions, it may actually de-motivate them from enhancing their business which in turn would improve the aesthetics of the downtown core.

Feedback from the board:

- -If the rationale of this approach is to encourage the redevelopment and enhancement of the downtown, should this not apply to AC Gas Station, BC Hydro, TELUS, The Legion, RCMP, the Museum and the Village of Pemberton?
- -Could the Village not work with the businesses to possibly provide an incentive to relocate and or improve the current aesthetics of their business? I.e. Relocation support, tax relief and or financial incentives?
- -Having these types of business in the downtown core of a small community when kept clean and professional is not necessarily a bad thing. Pemberton is a unique farming town among other things and we feel unique zoning & bylaws should reflect this.

Dear Mayor and Council

Re: C-3 zoning and request for permissible nightly rentals in the Pemberton Gateway building.

On October 6, 2018 I bought the Pemberton Gateway building and set out to turn the building around and make a positive impact in the community. In December 2017 it came to light that the way I, my lawyer and my realtor had interpreted the zoning bylaws was in fact different than the Village. As a result, my plan to provide a progressive flexible housing option responsive to the local market ground to a halt. Consequently, I chose to offer the condos for sale to residents in compliance with the Villages priority of making more room for permanent residents.

This has caused me to hold the property much longer than anticipated in which I've gleaned insight to how the building has filled a gap in accommodations within the community.

After writing a distressed plea letter for help, I was granted a transitional period allowing me to operate the unsold inventory for nightly rentals to pay the bills. I now would like to campaign for this specific building to continue in its current form as one that will provide both long term affordable accommodations while being responsive to changes in local transitional demand.

I believe that allowing us to be able to self govern and operate in a matter without restrictions will serve the community in 2 ways:

- 1) Provided more housing for residents in alignment wit the VoP's general community vision;
- 2) Support your economy by hosting tourists and housing your trade workforce.

While the lodge is nice, it is high priced. While the Pemberton hotel is very affordable, it is motel quality. There is nothing in between and this is where we fit in.

We are a priority choice for many labourers, government workers and extended stay family members. These people are patrons to many local businesses and return every year.

On May 1st I sat down personally with Lisa Pedrini, Sheena Fraser and Cameron Chalmers to discuss my opinions and requests. I was told that the Council's position on short term rentals is very inflexible, that Pemberton is not a resort community and that Council is not supporting short-term rentals outside of the residential neighbourhoods while being Primary residences.

I suggest there is a better way.

If the Pemberton Gateway is no longer operating any short-term rentals, 22 suites are effectively eliminated from the community's accommodation pool. That's going to increases prices for both the lodge and the hotel. It will create a duopoly resulting in accommodations that are less affordable; the very thing you wish not to do.

It is also very likely that due to demand, there will be more unauthorized short-term rentals popping up in undesignated neighbourhoods. As long as there is a demand for it, people will try and capitalize.

I am suggesting that we designated this building to allow it because it has always been operated that way, we have the right location for it, and we have the management experience to be able to enforce it.

It was asked of me if the current owners who bought into the building had notice that the building was operated this way and the answer is yes. I will point out section 2.1 and 2.2 in the disclosure statement where it describes this as well as Paragraph 7.2 in our purchase and sale contracts, in which every single owner has signed.

I am asking for the ability to offer nightly rentals in this building specifically, as well as the ability to own and live in it permanently full time. This is a way to open more homes to local residents while still maintaining the inventory for short term stays. Many buildings in Whistler have accomplished this successfully, (PHASE 1 restrictive covenant) and I believe we can effectively operating and co-live harmoniously. The management and enforceability would be restrictive to the Strata and not fall ono your workloads.

I have recently become a Chamber of Commerce Member and I have spoken passionately about this cause and been met with support advocating in this direction. I expect to involve the Chamber to be my voice and the voice of many others. For as many people that may not want to see this happen there are just as many that do. People want to live in the community. People also want to invest in the community, but sadly the long-term rents to cut it. The ability to rent out nightly is the bridge to making it affordable.

I also heard a comment that what the council does not want to see is a long-distance owner, say a Vancouverite, renting it out from afar. The feeling around this is that there is disbelief in the ability of a distant owner being a *good neighbour*.

Well, I am that Vancouverite that is managing 22 properties (now 15) from a distance.

I ask you this Mayor and Council, have I caused the Village any problems?

Have you received noise complaints from any of my guests/owners?

I have a record and contact information for every single guest and owner in the building and everyone has mine. I also run the building as a community having hosted new Owners for a social gathering and keeping everyone informed of events.

I have made personal monetary capital improvements around the building for the simple fact of elevating it's presence without knowing if I will earn those dollars back. This includes new hallway carpet and freshly painted walls. I have also removed 60 tons of garbage and junk that Myson had stored in the burrows of the building for 8 years, plumbed the entire building for in-suite laundry (which was a

massive undertaking having to cut holes in every single suites ceiling including coring the concrete of the commercial 1st floor to bring this option to owners) and done so on my own merit and cash. This endeavour has cost me near, but it is something I believe in for betterment of everyone's investment. I have paid for and cleaned up the parkade that quite literally likely has never been done (ever) and painting numbers on the stalls for ownership allocation. These improvements have costs me near \$80,000 all been done with my own cash out of the intention to make a small positive impact and leave the Pemberton Gateway better than it was before.

Myson Effa & Ela are no longer employed with me and I have replaced the cleaning crew, hired the Strata management co, am the Strata President and operating the remaining unsold inventory as short-term rentals single headedly. I also have a family and two daughters 6 & 8 years old.

So? Am I a bad neighbour? Is that Vancouverite having a rental investment going to be a bad landlord?

No. *That* person is going to be a poor neighbour based on who *they* are whether they live in the property or control it remotely.

My ask is that you grant us the ability to facilitate short-term rentals in the Pemberton Gateway Residences.

In Summary

"Notwithstanding" request

The Purpose

To modify and modernize the current zoning proposal to be in line with the needs and benefits of the community and to provide a dual-purpose solution to the economic situation.

The Needs

Affordable residential housing

Short-term accommodations to support the economy (i.e Housing trade workers, wedding guests, government workers, temporary staff housing, ski professionals, etc...)

The Problem

The current zoning only allows for one or the other and by doing so, it suffocates a lifeline on each end.

If it's all *Residential*, Pemberton loses 22 suites that it consistently relies upon.

If it's all *Hotel*, it voids the opportunity for young individuals and families to establish roots here contributing to overall growth and sustainability of the community.

Proposed Solution

Allowing for residential use, long term rentals or short-term accommodations (operating under a similar Phase 1 Covenant use)

Definition: Phase 1 rental pool covenants are less restrictive than Phase 2 rental pool covenants. Phase 1 covenants are intended to maximize occupancy of properties for use by owners and visitors. When not in owner use, the covenants generally require the accommodation units be made available to the public through a rental pool. For properties where the covenant does not specify a single, integrated rental pool, RMOW Council policy supports multiple rental booking and unit management arrangements within a property, including the self-management rental of units by owners

This building is the perfect pilot project as it's previous use and location offers a blended solution.

Market Research

There is a demand for both uses in this building? I sold units each way.

I sold 4 units immediately to local buyers under the *hotel* model before having to collapse them and redirect. I have now 4 contracts in place under the *residential* model.

It's obvious why the residential Buyers likes this property, but Buyers also liked the hotel model because it provided built-in housing for family members and staff housing while being able to rent it out when not in use. It was the perfect way to buy a piece of affordable real estate for their own use, have 100% control over it, renovate and improve quality as they see fit while also being able to pay the bills.

There is no currently no product available to do this. People want to invest and plan for their futures. They are going to do it anyways and this is an opportunity to keep their money in Pemberton.

The Negative Effects

Losing 22 short term accommodations may:

Cause rates to increase as supply decreases.

Reduced Tourism resulting in less clients for local businesses (ie: the wedding and food industry, and other service providers).

No place for trades to stay. The Gateway houses many trades that work on roads and build houses in the surrounding area. If there is no accommodates they cannot work.

Push more short-term accommodations into residential neighbourhoods.

Goal

Accommodate both needs through a flexible use bylaw.

This would allow The Gateway to serve multi-purposes and therefore sell to Owner-Occupiers and local Investors alike.

Re: The proposed removal of Drive - Through restaurants in the C-2 (Tourist Commercial) zone

We are the owners of 1443 Vine Road, Pemberton, a large vacant parcel of land located behind the Husky and McDonald's outlets. We purchased this property in September 2011 with the intention of developing the property for commercial uses allowed under the C-2 zoning to meet the growing needs of local residents and travelling public, and to contribute to the economic and social prosperity of the community.

In August 2017 we met with the Village of Pemberton staff to review our proposed mixed use development for the property which includes a Tim Hortons drive-thru restaurant. Please see attached site plan. Since then we have completed the geotechnical investigation of the property and have further refined our site plan. In all our discussions with the Village staff over the years there has been support for a drive-thru restaurant on our property.

We are opposed to the proposed removal of Drive-Through restaurants in the C-2 zone. We believe this is a short sighted proposal which will limit services to all the people living in the Village and the surrounding region including tourists and travelers. The proposal is discriminatory against properties like ours which currently allows for drive-thru restaurants. Should the proposed removal go ahead then one existing drive-thru restaurant in the Village will be given an exclusive and only drive-through business in this growing region.

Our proposed development is near completion for submission for a development (and rezoning for the residential portion) permit. We are requesting that at the very least our property be exempted from the proposed removal of Drive-thru use allowing us to proceed with our development.

We trust you will take our concerns and our opposition to the proposed removal into consideration before making a decision.

Message to Mayor & Council: I am writing to you to let you know that I am not in agreement with your plan to change the zoning of the properties where Valley Chainsaw and Black's Hot Wheels operate. I own the closest residential property to Valley Chainsaw (my lot is the one directly across from their front door but my address is Fernwood Street) and I have no complaints whatsoever about the noise. We do hear engine noise, but it is very minor and does not affect the enjoyment of our property whatsoever. In fact, I have actually never heard anyone I know in the downtown core make any complaints about the noise, so I question where this is coming from. We use Valley Chainsaw regularly for many of the services they provide and we hope to continue to do so for years to come. We love the accessibility of their location and we feel it is vindictive and unfair to downzone them in an attempt to have them move. We do not agree with the rationale to change the status of these semi-industrial uses to legal nonconforming, in hopes that this may encourage them to move out of the Town Centre and make room for more pedestrian-oriented commercial (retail or office uses) that rely on the day to day public. In fact, quite the opposite. We feel that the services that both companies provide are beneficial to other business in town because patrons of Valley Chainsaw and Black's Hot Wheels become patrons of the cafe's, restaurants and shops BECAUSE Valley Chainsaw and Black's Hot Wheels are there. I would be remiss to neglect to also note that I find the fact that the Mayor has plans to open a restaurant with a new and improved outdoor seating area in relatively close proximity to Valley Chainsaw a conflict of interest. I'm writing this letter in strong opposition to bylaw 832,2018. I am very concerned about the proposed changes to the new zoning bylaw that will make Black's Hot Wheels and Valley Chainsaw " Legal-non conforming " businesses by down zoning our "site specific" zoning . We both own our buildings and lots that we operate from, we bought them in good faith that our zoning would be secure.

In the minutes from April 26, 2018 Section 4 Subsection C (commercial zones) I was shocked to read "in hopes that this may encourage them to move out of town". This is not in the best interest of the community nor a respectable position for local government to take in relation to providing a fruitful business environment. This town is built on local community businesses, and to now find that we have local government whos position should be to encourage local business, is in fact unilaterally taking steps to make business intolerable in order to "encourage them to move out of town" is appalling. Considering the fact that the heritage of this town and foundational building blocks of Pemberton were due to the logging industry and still are, with Valley Chainsaw and Blacks Hot Wheels directly contributing to the well being and consistent servicing of the main industry of this town you would think that these businesses would be on the forefront of your consideration to maintain the stability of these establishments within the town center of Pemberton. Our customers and visitors love the fact that they can get their car fixed while they get their groceries, have lunch, or enjoy many of the other local business in town. The economic spin off that these two businesses bring to the down town core cannot be ignored. How many businesses have come and gone from this town in the last 20 years? Pemberton is a tough place to have a business, HIGH RENT, HIGHER TAXES and proximity to the city. These two businesses have stood the test of time which should show the need for them in this town. At the June 12th meeting when I asked how many towns do not have these services in them, was told "lots of towns" without citing one. I cannot think of one.

With regards to the letter that was presented to us by Lisa Pedrini, it stated that one of the main concerns for the Village was "the close proximity of your auto repair business to the Village's aquifer". I find this statement acrimonious at best. This establishment was here long before the well was in place, and the village would of had to have an environmental study completed prior to having a well drilled. If the position at that time was that there was not any environment concern or contamination in soil samples so as to go ahead with a costly venture of completing an aquifer, then the current assumption that this is now an issue is merely another tactic on behalf of the Village of Pemberton to exert its will to achieve its goal. At the meeting I was told by Niki Gilmore that I could apply for re-zoning in a similar to fashion as what

Bc Hydro had to do. However, as a small business and not withstanding the fact that I do not have the financial backing like Hydro, this is not very considerate. To that I have to ask, why change my zoning only to tell me that I can apply, with a significant cost to myself, to ask for rezoning. Not to mention that the application would probably not be entertained. I also have concerns about future building permits and if they would be granted for new construction. Again at the meeting on June 12th, Cameron who was in charge of creating the new By-laws said that it would be allowable. I would appreciate a letter stating that in writing as I would like to make improvements to the original building built back in the 50's.

To say that this zoning change will "encourage them to move out of the town" is a really shocking statement about businesses that has been here serving this community longer than most of you have been in Pemberton. This town was built around services like ours and Albert's. People love the fact that they can get their car fixed while they go get their groceries, go buy lawnmower parts, go have lunch or whatever, in this one stop shop town. It also is surprising that they would take our zoning away when the Village itself has it's own industrial works yard in the village just up the street from us.

When we bought this business it was run into the ground and no one wanted to come here. It was a sore spot in this town selling drugs and bringing a bad element into our town, it has taken ten years of our life to make it a thriving business again. We were happy to purchase the building when the time came because things were going well and we were tired of paying crazy rent. We pay our taxes, buy our business license every year and employ 7 people in this town who all spend money in this town. I feel that this council has forgotten who works for who and who pays their wages.

The VOP says that Valley Chainsaw and Blacks Hot Wheels are not retail outlets ,to that I wonder if they have ever been in either establishment. Tires are a retail item, but they have to get onto your vehicle some how. We provide that service. Valley Chainsaw is also 90% retail providing snowmobile, lawn and garden and saw parts to the public, they also provide repairs to such items as a service to the community.

In his Facebook post regarding this issue Mayor Richman stated that it is unsafe for children to walk past a parked loaded logging truck in front of Blacks on their way to school. How is that any more unsafe than children walking past a parked loaded lumber truck that is actively being unloaded by a forklift at Rona across the road? As for the safety of the aquifer why not work with Blacks to make sure they are in compliance with oil and other automotive fluid storage and removal. (Which I am sure they are)

To single out these two long time local businesses in this proposed bylaw and "encourage them to move out of the town centre" when there are other equally semi-industrial operators in town that are not included in the bylaw is blatantly discriminatory.

As the owners and operators of a farm up the Meadows we use both these businesses on a regular basis. Their location in town is convenient for us and our farm where getting things repaired or purchased in a timely fashion is crucial.

Blacks Hotwheels and Valley Chainsaw are a part of the fabric of our town. Treating them this way is just not okay.

We would encourage Mayor and Council to consider scrapping this proposed bylaw which is exclusive and come up with a plan that is inclusive for ALL businesses in Pemberton.

Dear Mayor and Council:

I am writing to express concern regarding the rezoning of Blacks Hot Wheels and Valley Chainsaw and Recreational Ltd.

It is beneficial to have these two businesses in the Village core for three key reasons: preservation of town identity, carbon footprint, and economy.

Town identity. These two businesses have been cornerstones of the Village of Pemberton, the Village core, for close to forty years. We are very lucky that Stephen and Robin Black (Blacks Hot Wheels) and Albert Bush (Valley Chainsaw and Recreational Ltd) are so dedicated to this community. They provide a community service to the town folk (such as myself), the Area C residents who live in the surrounding areas, and many visitors who come from all over the world. These two long-standing businesses are the backbone of the Village core and they are the bridge between the past, present, and future of the Village of Pemberton.

Carbon footprint. With these two shops located in the Village core, our carbon footprint is greatly reduced. Less fuel is burned as town is a one-stop-shop. In my case, I can even walk everywhere I need to go so therefore there are no unnecessary emissions released. However, if Valley Chainsaw was relocated, or worse, closed its doors, I would need to drive to an alternate location to purchase simple retail items such as belts, kits, helmets, chains, workwear, boots, oil, Aspen fuel, or that obsolete bolt that I need which Valley Chainsaw likely has tucked away in a back corner (might I add that this also part of the charm of our town). Moreover, if Blacks Hot Wheels was no longer located in the Village core, four times as much fuel would be burned (and emissions released) to drop my vehicle off as I would need a ride back to the Village core, and then upon job completion, a ride back to my vehicle only to have both vehicles drive back to town again. The thought of this possibility greatly disheartens me.

Economy. Blacks Hot Wheels and Valley Chainsaw draw locals, visitors, business and development into the Village core. With every snowmobiler and professional snow-sport athlete who arrives in the winter to every flat tire that shows up in the summer, the Village core benefits. The commonality between these people is that they spend money in our town: fuel, lodging, restaurants, supermarkets, sporting goods, General Store, pharmacy, health food stores, bakery, coffee shops, liquor stores, nursery, pet stores, and so forth. Then, these people fall in love with our vibrant community and come back. Many even pursue real estate. However, if Valley Chainsaw and Blacks were located elsewhere these same people would not go out of their way to leave the highway. They are compelled to enter the downtown core because they need service from one of these two establishments – Blacks or Valley Chainsaw. These two shops are critical to the health of our economy.

Thus, in closing, I am very concerned about the preservation of our town identity, the adverse effect of the carbon footprint, and the loss of economic revenue if the zoning bylaws are not amended to accommodate the inclusion of Blacks Hot Wheels and Valley Chainsaw and Recreational Ltd as they operate now, in the Village core.

The newly formed Pemberton Ratepayers Association (PRA) would like to take this opportunity to formally introduce ourselves. The PRA membership includes both citizens and local businesses.

Our mission statement is as follows:

"To represent citizens and businesses as an established and respected association that carries considerable influence in the community. To ensure concerns regarding governmental actions or inactions effecting Pemberton citizens and businesses are effectively and respectfully brought to Village planners, Mayor, councils and where appropriate request transparency and accountability from local government."

At this time the PRA has great concern regarding the zoning Bylaw # 832,2018 and formally request the following:

- I. Council cancels the public hearing and rescinds the readings of this Bylaw amendment based on the following:
 - a. The proposed Bylaw as presented will have a profoundly negative and deleterious impact on both the livelihoods of citizens and the business community at large.
 - b. The proposed Bylaw in itself is a very large, complex document and PRA feels strongly that there has not been adequate time given by the VOP to allow the public and the affected businesses to fully understand and provide comments or input on what impact this could have on them.

- c. The PRA suggests that there was a serious lack of consultation regarding this proposed Bylaw amendment.
- d. The PRA has great concerns regarding the lack of business representation on the ALUC.
- e. The PRA rejects this Bylaw and it's timing and respectfully asks the Mayor and Council to explain to our community why the Bylaw is being fast tracked and why such an unrealistic deadline was set for seeking input before the final reading.
- f. Recently the SLRD had a similar situation regarding their new Bylaw amendment and after hearing from the community they chose to hold a public information session that outlined in great detail all the proposed changes and are still in the consideration phase of their amendment. The PRA strongly feels that the Village should take the same approach to adequately address our above noted concerns.
- g. Once village businesses became aware of the proposed Bylaw on June 14th, 2018 a petition was published in both paper signature and online formats, Within 24 hours the petitions have received 1000+ signatures of support. This demonstrates a clear and very convincing show of support to have this Bylaw reconsidered by the VOP.
- h. If the village insists on following through or exploring the Bylaw further the PRA requests that an information report be circulated showing all of the proposed changes in a clear and concise manner, these should without exception be distributed to all local businesses that may be impacted in the Village boundary.
- Note that this is an election year and in a few short months there could be a new Mayor and Council that may have a different vision, one that reflects the interests of businesses and ratepayers of Pemberton.

PRA looks forward to working with the VOP in finding solutions to issues and others concerning the well being of the community.

The PRA respectfully asks for a prompt response to this letter due to the fast approaching date of the public hearing and the VOP imposed schedule to take this important matter to 3rd and 4th reading.

My name is Tanya Niet and I am writing to express my concern regarding the proposed rezoning of the Automotive Repair Shop and the Equipment Servicing, Rental and Repair Shop.

Although it was stated at the May 29th, 2018 Council meeting and published in the recent release of the FAQ for Zoning Bylaw No. 832, 2018 that states that these businesses "would be able to continue operating as a lawful non-conforming use", I still feel that it is a threat to their operations.

The reason I believe it is a threat to business as per usual in the aforementioned locations is because it was also noted in the minutes of the April 26th, 2018 Advisory Land Use Commission of the Village of Pemberton meeting that the rationale for the proposed rezoning, or "change of status", of the Automotive Repair Shop and the Equipment Servicing, Rental and Repair Shop was "in hopes that this may encourage them to move out of the Town Centre [to] make room for more pedestrian-oriented commercial (retail or office uses) that on the day to day public". Meanwhile, it was proposed that the Glass and Mirror Repair Shop and Gasoline Service Station "would be permitted to remain".

Thus, I agree with the sentiment of the petition that has been circulating in that "an amendment be made to the bylaw draft to allow Valley Chainsaw and Recreational Ltd and Black's Hot Wheels to remain in operation as per usual at their current locations". In other words, I support an amendment to zone these two enterprises as <u>site-specific permitted use</u> in the same way that the Glass and Mirror Repair Shop and Gasoline Service Station have been granted in the proposal. I support the idea of a subject to Conditions of Use clause for both the Automotive Repair Shop and the Equipment Servicing, Rental and Repair Shop:

The Equipment Servicing, Rental and Repair Shop is only permitted on lands legally described as Lot 7, Block 2, Plan 1624, DL 203, LLD at the adoption of this Bylaw.

The Automotive Repair Shop is only permitted on lands legally described as (insert title information) at the adoption of this Bylaw.

It seems to me to be a fair and logical amendment, particularly as both of these establishments have been pillars of the community for many years. Furthermore, it seems to me that the people are in agreeance with this sentiment as the petition numbers have shown.

My name is Chelsey Herechuk. I am sending this letter with concern regarding the new rezoning proposal, specifically regarding the lots where Valley Chainsaw & Recreational Ltd. and Black's Hot Wheels are located and operating.

The VoP posted a FAQ on Facebook about this proposal on June 15^{th,} not long after I posted a petition on Facebook through Change.org. This petition has more signatures than I thought it was ever going to produce. Showing me that the local population are not in favour of this proposal. I believe that these locations should be rezoned as <u>site-specific</u>, as to not interfere with these businesses which have stood strong in downtown centre for many years.

I have quoted the FAQ below (see Note 1) where the VoP states that this rezoning is not targeting these businesses to leave, but in the draft for the Advisory Land use Commission the exact words used are "hopes that this may encourage them to move out of the Town Centre." (see Note 2) The VoP has been replying to peoples comments on their Facebook post, but has not commented about that specific quote at all, even after being questioned about it. This comes across as though the VoP has no transparency with this issue for the general public, and as if they are trying to "cover there tracks" since it seems that document was not meant for the general public.

Is the Village targeting these businesses to push them out of town?

The Village is not targeting businesses. It is zoning land for the future based on its highest and best use. By removing these two site specific uses, the Village is attempting to implement certain objectives for Downtown outlined in the Official Community Plan, developed through extensive consultation with the Community in 2011.

Vancouver Coastal Health Authority (VCH) issues the Permit to Operate the water system and required that the Village prepare a groundwater protection plan (GPP) for their review as a condition of the Permit. The Village's GPP was prepared and recommends that the Village use developed planning tools (such as a Zoning Bylaw) to take specific precautions and eliminate the potential for contamination in the Village's Wellhead Protection Zone by transitioning this location to a low risk use. In addition, there are pedestrian and vehicular safety concerns with the operation of an Auto Repair Shop within the road and road right-of-way.

With respect to the Equipment Servicing, Rental and Repair Shop Use, the concern is the semi-industrial nature of this use, and the accompanying impacts of Outdoor Storage which is not a permitted use in the C-1 Zone.

The Village supports local businesses. In reviewing the Zoning Bylaw, the Village must balance the competing objectives of environmental and public safety

"...The rationale is to change the status of these semi-industrial uses to legal non-conforming, <u>hopes that this</u> <u>may encourage them to move out of the Town Centre</u> and make room for more pedestrian-oriented commercial (retail or office uses) that rely on the day to day public. These two (2) uses involve mechanical repair and associated outside storage and noise that is not conducive to a vibrant, walkable downtown where people want to both work and live. The other two (2) site specific permitted uses – Glass and Mirror Repair Shop and Gasoline Service Station, would be permitted to remain."

The proposed rezoning (Zoning Bylaw No. 832, 2018) to a lawful non-conforming designation has alarmed many of my suppliers with whom I have signed contracts, referred to as Dealer Agreements. These Agreements could be discontinued due to this proposed designation. The suppliers perceive the change in zoning as a risk. I am writing to express my opposition to the proposed bylaw to change the zoning of Valley Chainsaw & Black's Hot Wheels.

The minutes of the ALCU meeting of April 26, 2018 state:

"C (Commercial) Zones:

Pedrini explained some of the proposed changes in the C Zones. It was noted that two (2) of the four (4) site specific uses in the C-1 (Town Centre) Commercial Zone: Automotive Repair Shop and Equipment Servicing, Rental and Repair Shop will no longer be listed as permitted.

The rationale is to change the status of these semi-industrial uses to legal non-conforming, in hopes that this may encourage them to move out of the Town Centre and make room for more pedestrian-oriented commercial (retail or office uses) that rely on the day to day public.

These two (2) uses involve mechanical repair and associated outside storage and noise that is not conducive to a vibrant, walkable downtown where people want to both work and live.

The other two (2) site specific permitted uses – Glass and Mirror Repair Shop and Gasoline Service Station, would be permitted to remain."

The reason for the change in zoning is stated clearly here as a means to push these two businesses out of the town center. There is no mention of the water and safety issues that are now being sold as partial reasons for the change. I suspect because there really are none. If the Village is really worried about children potentially walking by a logging truck that's getting a tire changed, they should permanently block off the path the kids take over the train tracks which lead them in that direction. If it's worries about the water, why is the Gas Station not being rezoned as well? Or is that coming in the future? If there are complaints of noise and storage, why not use the bylaws that are already in place to deal with them?

I can't even conceive that the Village would single out two long standing businesses whose contributions to Pemberton are so numerous and varied. Their locations in the town center are vital to the working people and businesses of our community. The amount of traffic these businesses bring in to the town center cannot be understated. Valley Chainsaw is listed as "Equipment Servicing, Rental and Repair Shop" but as a former long-term employee, I'd hazard a guess that they sell more retail than half of all the stores in town combined. Not to mention the spin-off sales at other retailers in town because of their location.

The FAQ on the Village website answers the question of whether these businesses are being targeted by stating "The Village is not targeting businesses. It is zoning land for the future based on its highest and best use. By removing these two site specific uses, the Village is attempting to implement certain objectives for Downtown outlined in the Official Community Plan, developed through extensive consultation with the Community in 2011."

I would suggest that the land these businesses use are ALREADY being used to their highest and best use. Zoning for some unknown future use, with no mention of what that might be, does not make any sense. If these businesses are not being directly targeted (as you'd think per the ALCU meeting of April 26th) then just leave the zoning as/is.

2011 was seven years ago, and, as evidenced by the ever-changing and often empty retail spaces in town, it looks like the "certain objectives" the Village is trying to implement haven't exactly panned out. Luckily for us, there are still long time businesses such as Valley Chainsaw & Black's Hot Wheels to help carry the town center through tough times.

I strongly urge you all to put this portion of the proposed bylaw to rest and leave the zoning for Valley Chainsaw and Black's Hot Wheels as it is.

I wanted to let my views be known regarding the proposed rezoning of Valley Chainsaw and Black's Hot Wheels. I heard that these businesses may not remain zoned as site-specific permitted use. I heard that this means they can stay in operation but that they cannot make changes or upgrades to improve their businesses. I also heard that this rezoning was suggested so that Valley Chainsaw and Black's would hopefully feel inclined to move out to the Industrial Park.

This seems crazy to me because both places create economy. Black's keeps a lot of business is town. Black's is the first choice for many people because of the convenience of dropping your vehicle off while it is being serviced. Message to Mayor & Council: To the Mayor and Council, I am writing today to respectfully express my concern and absence of support for Zoning proposal bylaw No.832. I'll address the concerns I have surrounding this proposal; my main concern lies in the fact that there has been little to no actual transparency surrounding the motive for adopting this bylaw. When I read through the FAQ page, the Mayor's Facebook responses and the proposal it stated that the intention was in fact to NOT encourage the effected businesses out of town, rather to support them in continued operation. When I read the ALUC agenda it directly contradicted the written words of Mayor and council in stating "The rationale is to change the status of these semi-industrial use to legal non-conforming, in hopes that this may encourage them to move out of the Town Centre and make room for more pedestrian-oriented commercial (retail or office uses) that rely on day to day public. In my opinion, this is translating to me and to other voters and taxpayers in Pemberton that our elected body is working an angle behind the scenes to accomplish an agenda within the local government while telling us something else to avoid public opinion. The VOP has effectively deflected questions of substance regarding this issue while just refusing to answer others in public forums where we were encouraged to ask questions. I'm interested to know what the "but" is. -Does this proposed change affect land use? IE: would it hamper the businesses ability to store, park, display product and vehicles outside of the buildings? -Would there be new bylaws put in place in which the business owners could be fined for, at this time, unknown, non compliance's? Or are there existing bylaws for current "legal Non conforming" that could tell us what the actual changes would be? -What would be the immediate changes benefiting the VOP? Because as written, it looks as though there are no current changes but this bylaw wouldn't be proposed if there wasn't something more immediate that the Village is looking to accomplish. -These businesses could continue to run for the next 30 years, wouldn't that render this bylaw therefore irrelevant? -Would this bylaw would give the VOP more power to make changes in how these businesses are currently

operating? ie: by changing land use and restricting these businesses abilities to operate, in theory if the ability of the business to operate is greatly affected isn't that essentially "pushing them out"? This proposed bylaw is already having negative impacts on the effected businesses and permanent Pemberton residents like me. I am feeling disappointed and greatly concerned that the direction the VOP is taking will put actual people out of work and long time entrepreneurs out of business, if the goal is to "encourage them to move out of the town centre" as written and impact to the farming communities, local industries that rely on these businesses. I understand the argument is "but they can operate grandfathered in" but we all know this is not what the actual goal is after reading the ALUC agenda, we know that these businesses will be "squeezed" until they have no other option than to close down or relocate, it is our job to "look forward" after all. I am concerned that my government is valuing an idea that caters to the tourists/guests/passer throughs over the people who live and thrive here, we vote here, we pay taxes here and we support each other through thick and thin here and while I see the importance of tourism for our economy and revitalizing a growing town, it is not the most important thing and balance needs to be found through respectful solutions not bullying businesses out. Sometimes people have to come first even if they stand in the way of our vision for things, people before profit. Maybe we alter that vision to benefit everyone, some nice siding and solid fencing can do wonders for curb appeal, if the VOP would approve it. We banded together through flooding, through fire through everything, these businesses have been integral in assisting the needs of our people in crisis, providing sumps pumps, generators, transportation, maintenance of service vehicles etc at a moments notice and after hours. These are the types of businesses that also support the industry around us that is home to more local jobs. This does not only affect these business, there will be a ripple effect of how this is going to impact our community if these businesses are to be pushed out or "encouraged out" It would take massive cost, time, overhead etc into moving these small, family owned businesses to another location far away from the town centre and these are not corporations with vast amounts of money to just up and relocate. The most likely outcome would to be to close or try and sell something that is vastly restricted which would deflect financers, investors, suppliers etc which impedes the owners ability to even sell out of the business at a profit that would reflect the years and years of continued service to the Village of Pemberton, the SLRD, the ALR, MT Currie and beyond. I was born and raised in this corridor, as were my parents before me, I chose to work in health care to care for those in my community and I voted in people I thought had the same values and directives. 

Message to Mayor & Council: To Mayor and Council, I am writing this email to express my absolute support for the Village effort to enhance the downtown core of Pemberton (long overdue) and to ensure the safety of our shared aquifer (with absolute importance) and pedestrians (also critical). I have witnessed and participated in the tremendous amount of public engagement and consultation over many years to build the local vision improve the health and livability of our village, and give full hearted endorsement for the work to proceed. Besides the due process that has been held and honoured throughout the process to create a community-driven vision, I see the Mayor and Council as being accountable to uphold this vision and drive the forward movement for this vision/ commitment to proceed. This isn't about businesses that are inherently and obviously self-interested-- we must rise above the short sightedness of this limited thinking. This is about championing the health and wellness of the next and 7 generations to come. By continuing ahead, you: 1. protect our limited and precious water supply adjacent to current business activities with inherent risks to that very water supply (an unacceptable situation by all public health standards and flagged by our health authority) and 2. ensure not just 'livable' but healthy space for our growing children and habitants to enjoy and move freely in healthy patterns rather than avoiding unsightly/loud noises and almost industrial activity in livable neighbourhoods, and 3. Improve the overall welcoming nature of our little town that may have been resource dependent and tiny 30 years ago; but is rapidly shifting in its demographics to optimize a livable downtown space for the collective well-being. It is unreasonable and unfair to put the interests of 2 businesses (which in no practical way are compromised by the new zoning bylaw anyway) ahead of a collective process and a healthy and livable downtown core-- and I urge you to continue with your well executed plan to date that DOES reflect the silent majority. I am a 20 year resident, mother, tax payer, and professional remote worker with strong ties and loyalties in/to this town and view the proposed bylaw as a win-win for all. Thank you for considering this email and for your courage and strength to do what is right for the majority (and generations to come) and not move from fear/reactivity to appease 2 business owners (who can continue to serve their many happy customers —including me—-without disruption).

Dear Mayor and Council,

The proposed rezoning of Valley Chainsaw and Black's Hot Wheels Tire Shop and special provision given to three other businesses (AC Petroleum, the glass shop and a fitness organization) have just been brought to my attention. My first reaction is that the Village of Pemberton is again picking and choosing who and what they want in their boundaries like they did with their previous village expansion. Only when the village wanted the revenue from the IPPs did they realize that perhaps they should have consulted and included others in their process a long time ago. I am once again disappointed in the way mayor and council are working contrary to their desire for transparency, community, shopping locally and green initiatives.

Essentially, this is a small village, not even a town or city. A village is a place where everyone is welcome and you are able to truly do a one stop shop. When you drop off your lawn mower or get your tires changed and are waiting, you can get your groceries, check your mail and then because you have extra time even go for lunch or for coffee. I like having these services, even semi industrial ones, in the village because I interact with other people from my community especially those from other sectors and Area C residents. By gentrifying this small village, you risk losing many community interactions.

I think that when the lives of these businesses are faced with arbitrary restrictions, permits and laws, such as the option for expansion, resale limitations, and laws that prohibit rebuilding in the event of fire or flooding, their value and inclusion as a viable part of the downtown core is undermined. Also part of the historic character of Pemberton would be eroded. Valley Chainsaw, Black's Hot Wheels and Mountain Glass are 3 of the oldest buildings in the "downtown" core. If we lose them part of the historic Pemberton walking tour is removed. Added could be 3 more cinder block "city-like" buildings that do not add to Pemberton's quaint diversity.

If I am relegated to going to the industrial park for any services, I am becoming less green and adding to my "out of Pemberton" shopping list. My business and extra time are no longer in the village of Pemberton. It becomes considerably easier to go to Canadian Tire or Walmart for everything I need and there is a greater selection of restaurants for my meal. Ironically, my community interactions are also increased because I meet so many people from this village and Area C who choose not to shop locally. Also by accessing services in the industrial park, my

carbon footprint is substantially increased and my village interactions are equally decreased. Having semi industrial services in the village of Pemberton concretely supports farms and small agricultural operations that would fall under the village's jurisdiction if a boundary expansion was ever supported. Knowing that Tourism Pemberton advertises as a rural community (sheep named BB King and horses sauntering through town) with unique businesses, I assume all kinds of commerce would be openly welcomed into the downtown area..

If the services provided by Black's and Valley Chainsaw were not available and convenient, it would be interesting to see how many outdoor enthusiasts and off-road adventurers would not stop in the village of Pemberton. They would become another statistic that is prevalent across BC for small towns located in recreational or holiday areas. Get your supplies at Costco or in the city before you leave and never set foot in the local shops and community.

I was just in 100 Mile House and was astounded shop at the variety of the available goods and services in the shops. I was impressed with a range of services within a 1 or 2 kilometer strip, a sense of welcome, a diversity of buildings and the "community" feel even though I did not know a single person. I see why people are leaving Pemberton. Land value is not the only driving force. Convenient diversity within a community that is welcoming to locals and visitors is of equal or higher value.

I look forward to being part of the continued diversity in this ever changing community.
