### GENERAL TERMS AND CONDITIONS

*Open Air Fire Permits are valid until the end of current year, subject to the Permit Holder meeting the following conditions:*

- *Be present for the duration of the fire.*
- *Completely extinguish unattended fires.*
- *Take reasonable precautions to ensure the fire is contained such as a fire break.*
- *Ensure that they are equipped with an adequate supply of extinguishing agent.*
- *Always adhere to fire bans and restrictions.*

### ADDITIONAL REQUIREMENTS

**Campfires** (Note: Absolutely no fires during a campfire ban)

- *Campfire must be made of cured solid fuel such as split wood. Uncured yard waste is not permitted.*
- *Campfire must be no larger than ½ metre in diameter and ½ metre in height.*
- *Campfire is only allowed between 8am and 11pm.*

**Yard Waste** (Note: Only allowed for the month of April and between October 15<sup>th</sup> – November 15<sup>th</sup>)

- *Yard waste burning is only for the purpose of burning garden debris such as branches, leaves, tree clippings, grass and weeds.*
- *The fire must be no more than 2 metres in diameter and 1 metre in height.*
- *Fires may only occur when the Meteorological Services of Canada smoke ventilation index is 55 or higher.*
- *Yard waste burning is only allowed from dawn until dusk.*

### ACKNOWLEDGMENT

*I CERTIFY that I understand and will be guided by the Terms and Conditions, provisions of the Fire Permit Conditions (Bylaw No 744, 2013) and all applicable Provincial regulations and any conditions or restrictions imposed in the permit by the Fire Chief. I AGREE that I am responsible for fires authorized by this permit and any damage or damages to a person or property caused by an uncontrolled fire. All costs to extinguish a fire if the permit conditions are violated, including the cost of Pemberton Fire Rescue services and BC Ministry of Forests.*
