PURPOSE

The purpose of this report is to present to Council two proposed resolutions that were discussed at the Regular Council Meeting held on Tuesday, March 5, 2019. These resolutions are to be submitted by the Village of Pemberton for consideration by the Lower Mainland Local Government Association (LMLGA) at their Convention and Annual General Meeting to be held May 8-10, 2019.

BACKGROUND

At the Regular Council Meeting No. 1488, held Tuesday, March 5, 2019, discussion took place respecting submitting resolutions to LMLGA to inspire action on issues important to local governments.

As a result, the following resolution was presented for consideration and endorsed by Council:

Moved/Seconded

THAT the following resolution be submitted for consideration by the Lower Mainland Local Government Association:

WHEREAS the negative impacts to lower mainland Provincial parks and Crown Land recreation areas continue to occur due to increasing tourism and limited funding:

THEREFORE BE IT RESOLVED that the Province be requested to allocate additional funding to managing B.C. Parks, specifically Joffre Lakes Provincial Park, and Crown Land recreation areas in the Sea to Sky Corridor and Lower Mainland.

CARRIED

The resolution noted above has been submitted to the LMLGA for consideration as of March 15, 2019. As well, it was agreed that it would be of value to submit resolutions requesting consideration of First Nations participation on local commissions and to be eligible for grant funding under emergency preparedness initiatives. In this regard, the following resolution was passed:

It should be noted that submissions related to resolutions considered and forwarded by local area associations to UBCM, or those already considered at previous UBCM Conventions where direction was provided and a response from the Government received, will not be entertained in order to avoid duplication.

DISCUSSION & COMMENTS:

As per the direction above, Staff has prepared two resolutions for Council's consideration for submission to LMLGA respecting the following:

Resolution #1 - Request for First Nations participation on Commissions

WHEREAS the Village of Pemberton, in partnership with the regional district, other local governments, and First Nations in the Sea to Sky area are working collaboratively to develop a regional transit commission to establish a regional transit system to connect Mt. Currie to Metro Vancouver;

AND WHEREAS the current provincial transit commission model does not allow for representation from First Nations which does not allow for an equal representation or an equitable decision making platform process;

THEREFORE BE IT RESOLVED THAT the Province of British Columbia amend the legislation respecting the representation on commissions to include First Nations.

Resolution #2 – Request for First Nations eligibility for emergency preparedness grant funding through UBCM

WHEREAS the Village of Pemberton, in partnership with the regional district, and First Nation in the Pemberton Area are working collaboratively on emergency preparedness and response initiatives;

AND WHEREAS in order to identify and prepare response and put in place mitigation measures, significant costs are associated with the work;

AND WHEREAS UBCM offers grant funding through the Community Emergency Preparedness Fund for such initiatives that are available to local governments, but not to First Nations;

THEREFORE BE IT RESOLVED THAT UBCM [or the Province of BC or both] amend the eligible applicants to include First Nations.

COMMUNICATIONS

If the resolutions noted above are supported correspondence will be sent to LMLGA with a request to have the resolutions put forward at the Convention and AGM in May. There are no further communication components required at this time.

As owners of Pemberton Self Storage, in the Pemberton Industrial Park, we are concerned with the current mil rates, our current BC Assessment, and the potential, substantial increase in our property taxes. We have filed an appeal with the BC Assessment board and that is in progress. At Current mil rates our potential property tax rate will be overwhelming and will put us out of business.

Our business plan and budget were based on a much lower assessment - the current assessment and mil rate will put our taxes in excess of \$38,000 annually.

Being in our first year of business aside, this kind of expense is excessive and we feel the VOP needs to fully recognize the impact that this could have on our business and all businesses currently in operation.

What we are looking for by writing this letter is acknowledgment of the looming financial crisis and some sort of mitigating decisions from council that will allow us to stay in operation. We have invested everything we have in Pemberton and don't want to be forced out by taxes. We are not sure how to proceed and would appreciate some guidance on what steps we can take.

Dear Premier Horgan,

I am writing on behalf of Victoria City Council, requesting favourable consideration and resolutions of support for the extension of vacancy taxation authority to local governments.

At the January 17, 2019 Council Meeting, Council approved the following resolution:

WHEREAS the Province of British Columbia responded to a housing affordability crisis in 2016 with legislation empowering the City of Vancouver to introduce a surtax on vacant residential properties, resulting in \$38-million in revenues for that community in 2018 and creating a strong disincentive to leaving properties vacant;

AND WHEREAS communities across British Columbia face housing affordability pressures, while a portion of the housing supply in all communities remains vacant, including properties that have remained derelict for years or decades;

AND WHEREAS vacant and derelict buildings pose substantial risks in terms of public safety in communities, as well as liveability and desirability for nearby and adjoining neighbourhoods and properties;

THEREFORE BE IT RESOLVED THAT the Province of British Columbia extend the authority to introduce a surtax on vacant residential properties to local governments across British Columbia, providing communities with the discretion to decide whether to introduce an additional tax to discourage vacant and derelict buildings, and encourage the occupancy, maintenance, and improvement of buildings to address housing affordability and public safety.

2018 B72 Backcountry Tourism

Whereas the rapidly increasing popularity of adventure tourism is having adverse impacts to the natural environment, such as increased human/wildlife conflicts, the closures of popular destinations to unmanageable volume, garbage, and an increased risk of wildfire in remote areas:

Government is supporting the adventure tourism sector through a cross-ministry working group and ongoing engagement with the Adventure Tourism Coalition of 19 sector associations representing nature-based experiences across the province.

Government is also supporting the strategic development of tourism through the Destination Development Planning program being led by Destination BC. This initiative, currently in the second year of a three-year program, will result in the creation of 10-year tourism development plans for 20 distinct areas across the province.

Partner ministries are also investing in infrastructure to support outdoor recreation and adventure tourism. BC Parks has operational and campsite expansion budgets that include projects and facilities in backcountry areas. An additional \$1 million has been approved for 2018-19 for backcountry facility investment.

Recreations Sites and Trails (RST) in the Ministry of Forests, Lands, Natural Resource Operations and Rural Development manages trails and facilities on Crown land outside of parks, and has an estimated budget of \$11 million for 2018-19. This includes \$650,000 in funding to support maintenance, \$1.4 million capital investment in new and renovated infrastructure, and \$1.8 million as part of a campsite expansion project.

Where use levels and demand warrant, BC Parks and RST are implementing reservation systems for high demand recreation sites, particularly on the coast. Rather than consider reservations and fees for trails, RST is piloting work on implementation of a comprehensive Visitor Use Management Framework to better guide decisions on approvals, management and investment in recreation infrastructure.

2018 B108 International Biodiversity Targets Commitment

Whereas the federal government has committed to meeting the International Biodiversity Targets of protecting 17% of our land and inland waters and 10% of our ocean by 2020 through networks of protected areas and other effective area-based conservation measures;

And whereas a strong provincial parks system provides economic benefits in the forms of good jobs in urban and rural communities, economic impacts through visitor spending, tourism revenue and diversifying the economy, and ecosystem services in the forms of clean air, water, providing critical habitat for species-at-risk, and climate change adaptation:

Therefore be it resolved that UBCM request the provincial government to set aside dedicated funding for purposes of system expansion, ecological monitoring and research, and management planning to meet the quantitative and qualitative measures set out in the 2020 Biodiversity Goals and Targets for Canada.

8) The Chair will recognize the questioner and will direct questions to the Councillor whom he/she feels is best able to reply;

9) More than one Councillor may reply if he/she feels there is something to contribute.
