

COVID-19 TERMS AND CONDITIONS

The following required terms and conditions, as applicable, require user compliance and must be adhered to in order to obtain a Facility, Park, Field and/or Public Space.

SECTION #1: COVID-19 Public Health Requirements

It is the organizers responsibility to comply with all rules and regulations from the Provincial Health Officer, and any other applicable authority or law such as Vancouver Coastal Health, WorkSafeBC and any Provincial/National Sport Organizations, designed to reduce the potential of contracting or transmitting COVID-19. Further, it is the organizers responsibility to meet changing or new COVID-19 regulations as the regulations are subject to change from the date of the booking and the date of the event/activity occurring.

Organizers must inform the Village of precautions they are taking for their event or activity that reduce the risk of transmission of COVID-19 by submitting a COVID-19 Safety Plan. Organizers will comply with all applicable aspects of the Village of Pemberton COVID-19 Safety Plan, available for review at <https://www.pemberton.ca/municipal-services/covid-19-business-preparedness> and acknowledge that services and permissions the Village provides may change as per direction from the PHO or other authorities. The Village reserves the right to cancel an event/activity for which a Rental Agreement has been issued at any time for safety reasons. The organizer may also cancel the event without penalty.

Finally, the organizer is responsible to collect and retain a list of participant contact information in the event that a PHO needs to perform COVID-19 contract tracing.

The following protocols must be acknowledged and adhered to:



SECTION #2: Attendees and Activities

All events that are considered gatherings are limited to maximum of 50 people as per the Provincial Health Officer. To support physical distancing requirements, the maximum number of attendees permitted in some public spaces is lower than 50, and some types of activities may not be permitted. Any person who feels sick should not attend events or activities on Village premises. As organizer, please inform attendees that they should not participate if they have:

- Experienced cold or flu-like symptoms within the last 14 days
- Been in close contact with anyone who has been diagnosed or a presumed case of COVID-19
- Travelled outside of Canada in the last 14 days

SECTION #3: Informed Consent

COVID-19 is a highly infectious disease with a latent period of transmission during which time even apparently healthy people can be infectious. COVID-19 is a potentially fatal disease affecting people of all ages and can be significantly more dangerous in people of already compromised health. It is the responsibility of each individual to decide whether to participate in event/activities. By attending an event or activity in a Facility, Park, Field or Public space, individuals will be at risk of contracting COVID-19, despite any precautions taken by the organizer or by Village staff.

In acknowledgement of this risk, the Organization releases, indemnifies and saves harmless the Village of Pemberton, council members, officers, employees and agents from and against all liabilities, actions, damages, claims, losses, costs and expenses whatsoever (including without limitation, the legal fees and disbursements) in any way directly or indirectly arising out of or caused, in whole or in part, by the Organization and its directors, officers, employees, volunteers, contractors, agents, successors, assigns and members in the use of Facilities, Parks, Fields and/or Public spaces.

All permit holders and participants must follow all Village of Pemberton health and safety protocols, whether they are communicated verbally or in writing, designed to ensure the safety of activity participants, members of the public and Village staff.
