

# PUBLIC PARTICIPATION IN COUNCIL MEETINGS IN CONFORMANCE WITH PHYSICAL DISTANCING REQUIREMENTS

To minimize the spread of the COVID-19 virus, the Village of Pemberton is providing an alternative to viewing Council, Committee, and Board meetings, allowing for public participation during Regular Meetings only, as per the Village's <u>Open Question Period Policy</u>. This alternative allows the Village to adhere to physical distancing requirements, follows the Minister of Public Safety's Ministerial Order M0192 (which suspends certain requirements of the *Community Charter*), and provides a way for the public to ask questions during the Open Question Period at the end of a Regular Council meeting.

Please be advised, all electronically held Council, Committee, and Board Meetings are recorded. Please read the <u>Video Recording & Broadcasting Policy for Electronically held Council, Committee and Board Meetings</u>.
