### 4.1 Nkwúkwma Sub-Area Plan. Introduction

At 3:02pm Cameron Chalmers, Planning Consultant, joined the meeting remotely.

Mr. Chalmers introduced the first draft of the Nkwúkwma Sub-Area Plan which is being presented in advance of additional public consultation and upcoming Committee of the Whole workshops.

Mr. Chalmers presented background information of the plan and the following process to date noting that:

- The initial site and land use information collection process is complete including internal and external referrals.
- The servicing and utilities information collection process is nearing completion.
- Two initial rounds of public consultation have been held by the applicant as summarized in the consultation submission. Additional consultation anticipated through next stage of process.
- The information has been synthesized and consolidated into the first draft of the Nkwúkwma Sub-Area Plan.

Mr. Chalmers advised that next steps will include:

- A public open house to provide an update on the development proposal and introduce the Nkwúkwma Sub-Area Plan and seek feedback from the community
- At Committee of the Whole Workshop in late April/ early May to present the community feedback.
- Additional processing steps. consultation and council workshops to be determined.

- Permit Development guidelines
- Lil'wat Nation open house and consultation
