VILLAGE OF PEMBERTON BYLAW No. 986, 2025

A bylaw to establish the annual tax rates for municipal, regional district and Sea to Sky Regional Hospital District purposes for the year 2025.

The Council of the Village of Pemberton, in open meeting assembled, ENACTS AS FOLLOWS:

CITATION

1. This bylaw may be cited as the "Village of Pemberton 2025 Annual Tax Rates Bylaw No. 986, 2025."

PURPOSE

The purpose of this bylaw is to establish the annual tax rates for municipal, regional district and Sea to Sky Regional Hospital District purposes for the year 2025.

SCHEDULE

3. Schedule A is attached to and forms part of this bylaw.

GENERAL

- 4 (1) The following rates are hereby imposed and levied for the year 2025:
 - (a) For all lawful general purposes of the municipality on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in column A of Schedule A.
 - (b) For purposes of the Squamish-Lillooet Regional District on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in column B of Schedule A.
 - (c) For purposes of the Sea to Sky Regional Hospital District on the assessed value of land and improvements taxable for hospital purposes, rates appearing in column C of Schedule A.
 - (2) The minimum amount of taxation upon a parcel of real property shall be one dollar (\$1.00).
