A bylaw to authorize the levying of rates and charges for the use of the sanitary sewer system.

The Council of the Village of Pemberton, in open meeting assembled, **ENACTS AS FOLLOWS**:

CITATION

 This bylaw may be cited for all purposes as the "Village of Pemberton Sanitary Sewer System Rates, Rents and Charges Bylaw No. 987, 2025."

PURPOSE

2. The purpose of this bylaw is to authorize the levying of rates and charges for the use of the sanitary sewer system.

SCHEDULE

3. Schedule A is attached to and forms part of this bylaw.

GENERAL

- 4 (1) The rates, rents and charges payable commencing January 1, 2025 by all persons whose premises are connected with the Village sanitary sewer system shall be those set out in Schedule A.
 - (2) Utility billing is done on an annual basis providing residents the option to pay monthly, quarterly, or annually before the tax due date of the billing year.
 - (3) A 10% penalty will be added to such rates, rents and charges remaining unpaid after the tax billing due date of the billing year.

REPEAL

4. This bylaw repeals Village of Pemberton Sewer Rates, Rents and Charges Bylaw No. 964, 2024.
