VILLAGE OF PEMBERTON BYLAW NO. 990, 2025

A bylaw to provide for alternative means of publishing statutory notices

The Council of the Village of Pemberton, in open meeting assembled, **ENACTS AS FOLLOWS**:

CITATION

1. This bylaw may be cited for all purposes as the "Village of Pemberton Public Notice Bylaw No. 990, 2025".

INTERPRETATION

Definitions

- 2. In this bylaw:
 - (a) council means the council of the Village of Pemberton;
 - (b) *local newspaper* means the print edition of the Pique Newsmagazine or another weekly newspaper serving Pemberton;
 - (c) Village means Village of Pemberton;
 - (d) Village Community Newsletter means a regularly issued publication in electronic form, used to communicate news, updates, and information relevant to residents within the community:
 - (e) Village office means the premises located at 7400 Prospect Street, Pemberton, B.C., and
 - (f) Village website means the Village primary online information resource found at www.pemberton.ca.

Interpretation

- 3 (1) The <u>Interpretation Act</u> applies to this bylaw.
 - (2) In this bylaw, a reference to an *Act* refers to a statute of British Columbia and a reference to any statute, regulation or other enactment refers to that enactment as amended or replaced from time to time.

Severability

4. If any definition, section, subsection, paragraph, subparagraph, clause or phrase in this bylaw is held invalid by a court of competent jurisdiction, the invalid definition, section, subsection, paragraph, subparagraph, clause or phrase must be severed, and the remainder of this bylaw is deemed to have been adopted without the severed definition, section, subsection, paragraph, subparagraph, clause or phrase.

Purpose

5. The purpose of this bylaw is to establish alternative methods for providing official public notice under section 94.2 of the *Community Charter*.

GENERAL

- 6 (1) The means of publication for public notice requirements under section 94 of the *Community Charter*, *Local Government Act*, or any other enactment shall be delivered in the following form and manner:
 - (a) by publishing it in the local newspaper at least seven (7) days prior to consideration of the matter by the Village Council, or if it is not regarding a matter to be considered by Council, otherwise in accordance with the publishing requirement; and
 - (b) by publishing it on the Village website at least seven (7) days prior to consideration of the matter by the Village Council, or if it is not regarding a matter to be considered by Council, otherwise in accordance with the publishing requirement.

READ A FIRST TIME this 24th day of June, 2025.

READ A SECOND TIME this 24th day of June, 2025.

READ A THIRD TIME this 24th day of June, 2025.
