a) Community Health – Geoff McKee, Medical Health Officer, Vancouver Coastal Health

Dr. McKee provided an overview of his work as the Medical Health Officer overseeing the coastal-rural areas of the Sea to Sky Corridor, Sunshine Coast, Powell River, Bella Bella and Bella Coola.

Dr. McKee's focus has been to collaborate with local governments, education facilities and community groups to promote healthy communities and address community-level issues such as safety, social well-being, prevention, and access to care. Ongoing initiatives include the My Health My Community Survey, which gathers data on individual communities' health and well-being, and the upcoming Sea to Sky Healthy Communities Congress.
