5. ECONOMIC DEVELOPMENT STRATEGY AND ACTION PLAN – REQUEST FOR PROPOSAL REVIEW

Jill Brooksbank, Senior Communications & Grant Coordinator, presented the draft Request for Proposal (RFP) for the Committee's consideration and advised that a grant application for funding to facilitate this initiative has been submitted in addition to the funds allocated in the 2019 budget.

Discussion took place respecting the list of key deliverables outlined in the RFP, including prioritizing point (e) (identifying the regions assets and competitive advantages) and de-emphasis of point (b) (review and analyze existing demographic and socio-economic data).

It was noted that further comments and ideas would be deliberated as part of the consultation period with the successful proponent of the RFP.

Staff will prepare an updated RFP for issuance.

6. ANIMAL CONTROL BYLAW REVIEW AND DRAFT AGGRESSIVE DOG DESIGNATION POLICY

Sheena Fraser, Manager of Corporate & Legislative Services, provided the Committee with the results of Staff's review of the Animal Control Bylaw, revision of the Bylaw Enforcement Policy, and draft Aggressive Dog Designation Policy.

The Committee had no concerns related to the proposed Aggressive Dog Designation Policy and Procedure or the amendments to the Bylaw Enforcement Policy.

The Committee indicated that it would be beneficial to add a definition of "minor injury" to the Bylaw. Some concerns were voiced around the dangerous dog provisions within the Village's Bylaw, particularly the Village's role in regulating dangerous dogs within the community.

The Committee asked that Staff do more research and further review of the Animal Control Bylaw and Aggressive Dog Policy with respect to these comments, and passed the following resolution:
